What is Cellular Therapy?

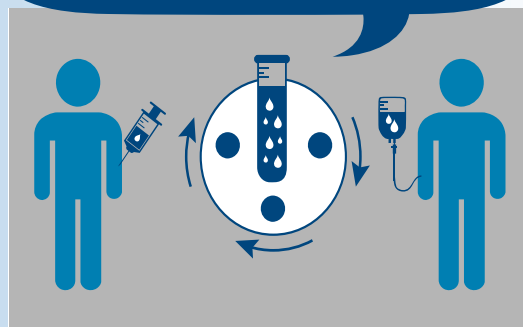


A type of treatment for cancers of the blood (leukemias), bone marrow, and lymph nodes
